

AMENDMENT TO THE AGREEMENT WITH THE CITY OF MURRIETA AND CONSULTANT

Original Agreement Title ("Agreement"): Agreement Between the City of Murrieta and Care Solace, Inc.

Agreement Termination Date: August 15, 2026

Brief Description of Scope of Services ("Services"): Mental health and social service coordination services

This Amendment to the Agreement, effective on August 14, 2026, by and between the City of Murrieta, a Municipal Corporation, duly organized and existing under and by virtue of the laws of the State of California ("City"), and the above referenced Consultant with reference to the following facts which are acknowledged by each party as true and correct:

RECITALS

Whereas, City is a general law city, formed and existing pursuant to the provisions of the California Government Code.

Whereas, City and Consultant entered into an Agreement on the Effective Date set forth above for the Services.

Whereas, City and Consultant wish to amend the Agreement, which was previously amended twice, as further set forth herein.

AMENDMENT

NOW, THEREFORE, it is agreed by and between the parties as follows:

1. The above recitals are true and correct
2. The following terms of the Agreement are hereby amended to read as follows:

Paragraph 3.1.1 is added:

"3.1.1 Notwithstanding anything to the contrary in Paragraph 3.1 of the Agreement, the parties wish to exercise a third one year extension to the Agreement. The term of the third extension shall be from August 15, 2026 through August 14, 2027." and

Paragraph 4.1 of the Agreement is amended to read as follows:

"4.1 Consideration. In consideration of the services to be performed by CONSULTANT for the CITY as set forth in Section 1, the CITY agreed to pay CONSULTANT the sum of one hundred sixty-six thousand five hundred dollars per year (\$166,500/annually) through August 15, 2025; one hundred thousand dollars (\$100,000.00) for the period of August 15, 2025 to August 15, 2026; and one hundred twenty-five thousand

dollars (\$125,000) for the period of August 15, 2026 to August 15, 2027. The total not to exceed sum of this Agreement will be five-hundred fifty-eight thousand dollars (\$558,000)."

3. All other conditions of the Agreement shall continue in full force and effect.
