Paragraph 3.1 of the Agreement is amended in its entirety to read as follows: "The term of the agreement shall be from July 1, 2022 through June 30, 2027."

Paragraph 4.1 of the Agreement is amended in it entirety to read as follows:

"In consideration of the services to be performed by CONSULTANT for the CITY as set forth in Section 1, the CITY agrees to pay CONSULTANT per individual project at rates set within

Exhibit "B", attached hereto and incorporated herein, not-to-exceed a total cumulative fee of \$110,000.00 (One Hundred and Ten Thousand Dollars and Zero Cents) for the term of this Agreement."

3. All other conditions of the Agreement shall continue in full force and effect.
