

RESOLUTION NO. 25-4846

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MURRIETA,
CALIFORNIA, ACCEPTING THE FISCAL YEAR 2024 EMERGENCY
MANAGEMENT PERFORMANCE GRANT PROGRAM AWARD AND
AMENDING THE FISCAL YEAR 2024/25 OPERATING BUDGET TO
ALLOCATE AND APPROPRIATE THE GRANT FUNDS**

WHEREAS, on June 6, 2023, the City Council of the City of Murrieta adopted Resolution No. 23-219, approving the operating budget for fiscal years 2023/24 and 2024/25 (Operating Budget); and

WHEREAS, the City of Murrieta Fire Department submitted a grant application to the County of Riverside Office of Emergency Services under the U.S. Department of Homeland Security; and

WHEREAS, on April 23, 2025, the City of Murrieta received a grant award for the Fiscal Year 2024 Emergency Management Performance Grant Program in the amount of \$15,503 (the “Grant”); and

WHEREAS, the terms of the Grant provide a dollar-to-dollar local match requirement, totaling \$15,503; and

WHEREAS, sufficient funds are available for the local match requirement in the Murrieta Fire District’s 2024/25 Operating Budget.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MURRIETA,
CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS**

Section 1. The recitals above are true and correct and incorporated herein by this reference.

Section 2. That the City of Murrieta accepts the grant award of the Fiscal Year 2024 Emergency Management Performance Grant Program in the amount of \$15,503 including the terms of the grant.

Section 3. That the Fiscal Year 2024/25 budget, as adopted by Resolution No. 23-219, is amended by allocating the Fiscal Year 2024 EMPG funds to reflect this Homeland Security grant revenue and the expenditure budget and increasing the grant revenues and the grant expenditure budget by \$15,503 in Fund 377.

Section 4. That the City Manager, or his designee, is authorized to sign and submit all necessary grant-related documents and take actions required to accept and implement the grant.
