

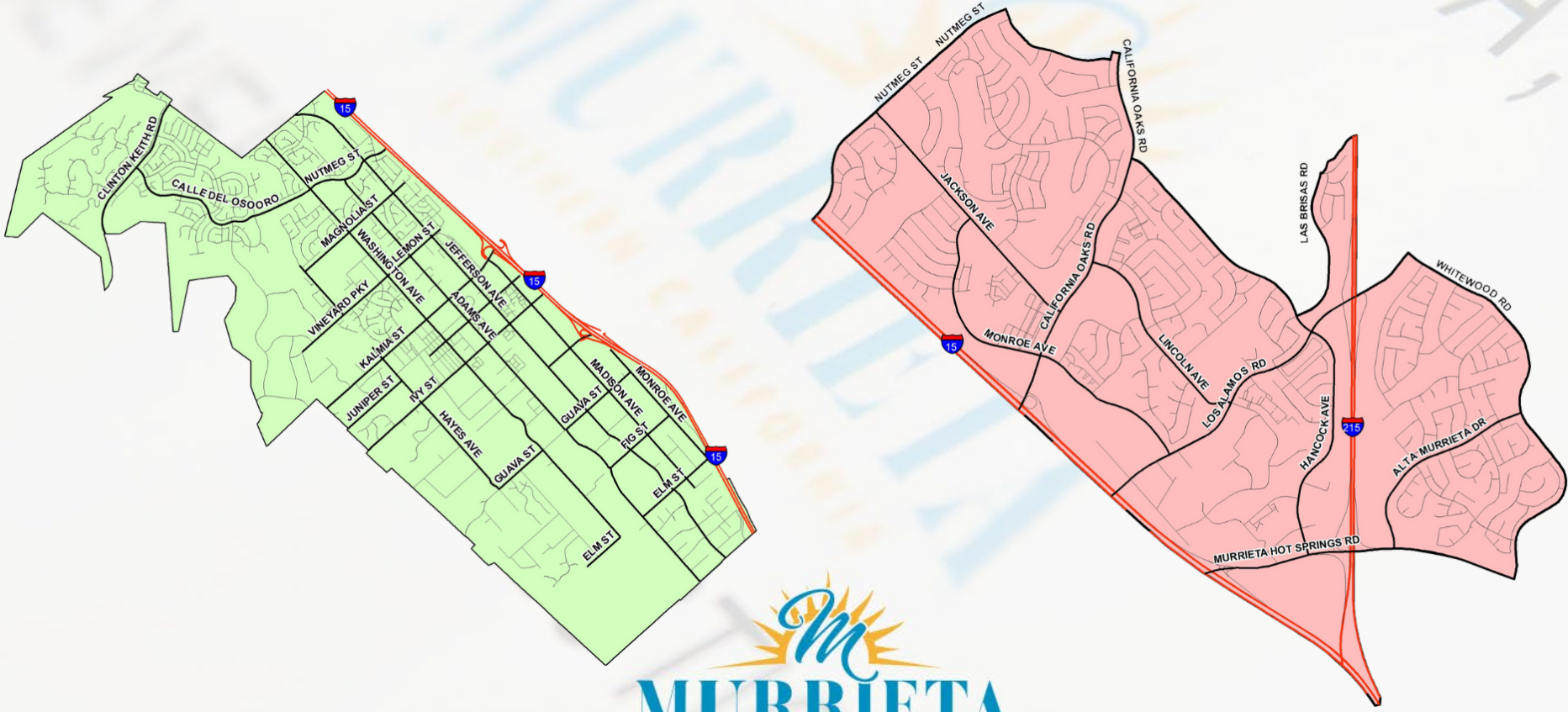

- **2020 – General Municipal Election for District Nos. 3 and 4**
- **2021 – Appointment of District 5 Representative due to vacancy**
- **2022 – General Municipal Election for District Nos. 1,2, and 5**
  - 2022 – Appointment to the District 1 Office and canceling the election for the District 1 Office
- **2024 – Upcoming General Municipal Election for District Nos. 3 and 4**

# Resolution No. 24-4763

*A Resolution of the City Council of the City of Murrieta, California, Calling for the Holding of a General Municipal Election to be Held on Tuesday, November 5, 2024, for the Purpose of Electing Certain Officers of Said City as Required by the Provisions of the Laws of the State of California Relating to General Law Cities; and, Other Election Matters as Required by Law*

Purpose:

- Calls the Election
- Procedure to resolve tie vote
- Affirms City Clerk as Local Election's Official



# Resolution No. 24-4764

***A Resolution of the City Council of the City of Murrieta, California, Requesting the Board of Supervisors of Riverside County to Consolidate a General Municipal Election to be Held on November 5, 2024, with the Statewide General Election to be Held on Same Date Pursuant to §10403 of the California Election Code and Other Election Matters as Required by Law***

Purpose:

- Requests consolidation with the County
- Set which office is to be voted for
- Acknowledges process of the consolidation will be held as the same procedures of the statewide election.



# Resolution No. 24-4765

***A Resolution of the City Council of the City of Murrieta, California, Adopting Regulations for Candidates for Elective Office, Pertaining to, and Costs of, Candidate Statements Submitted to the Voters at the Consolidated General Municipal Election to be Held on Tuesday, November 5, 2024***

Purpose:

- Regulations for Candidate Statements
- Candidate Statements are optional, and the cost is the responsibility of the candidate:
  - 200 words ~ \$400 (Option A)\*
  - 400 words ~ \$600 (Option B)\*
- Translation cost TBD



*\* Estimates based on the past cost trends from 2020 and 2022*

# Nomination Period

*July 15 (8:00 A.M.) through August 9, 2024 (5:00 P.M.)*

## California Elections Code §10220

- Not earlier than the 113th day nor later than the 88th day before a municipal election during normal office hours, as posted, the voters may nominate candidates for election by signing a nomination paper.

## California Elections Code §10224

- All nomination papers shall be filed with the city elections official during regular business hours as posted, not later than the 88th day before the election.



# Extension of Nomination Period

## California Elections Code §10225

### Incumbents Eligible for Reelection

- District 3 – End of First Term 2024
- District 4 – End of First Term 2024

**Deadline extended to Wednesday, August 14, 2024, at 5:00 P.M.**

**ONLY IF INCUMBENT DOES NOT FILE**

- **Schedule Appointment**

- Qualifications
- Official nomination paper issued
- Additional filing requirements



# Filing Nomination Papers

*(July 15 – August 19, 2024)*

- **Schedule Appointment OR Walk-In**

- Contact the City Clerk at (951) 461-6031, (951) 461-6030 or [CityClerk@MurrietaCA.gov](mailto:CityClerk@MurrietaCA.gov)
- Schedule appointment at the conclusion of pulling Nomination Papers

- **Expect 30-45 minutes**

- Confirm and review all required paperwork
- Affidavit of Nominee & Oath/Affirmation of Nominee is given
- Voter signature verification process begins

- Direct the City Clerk to fulfill any administrative requirements in accordance with the law.





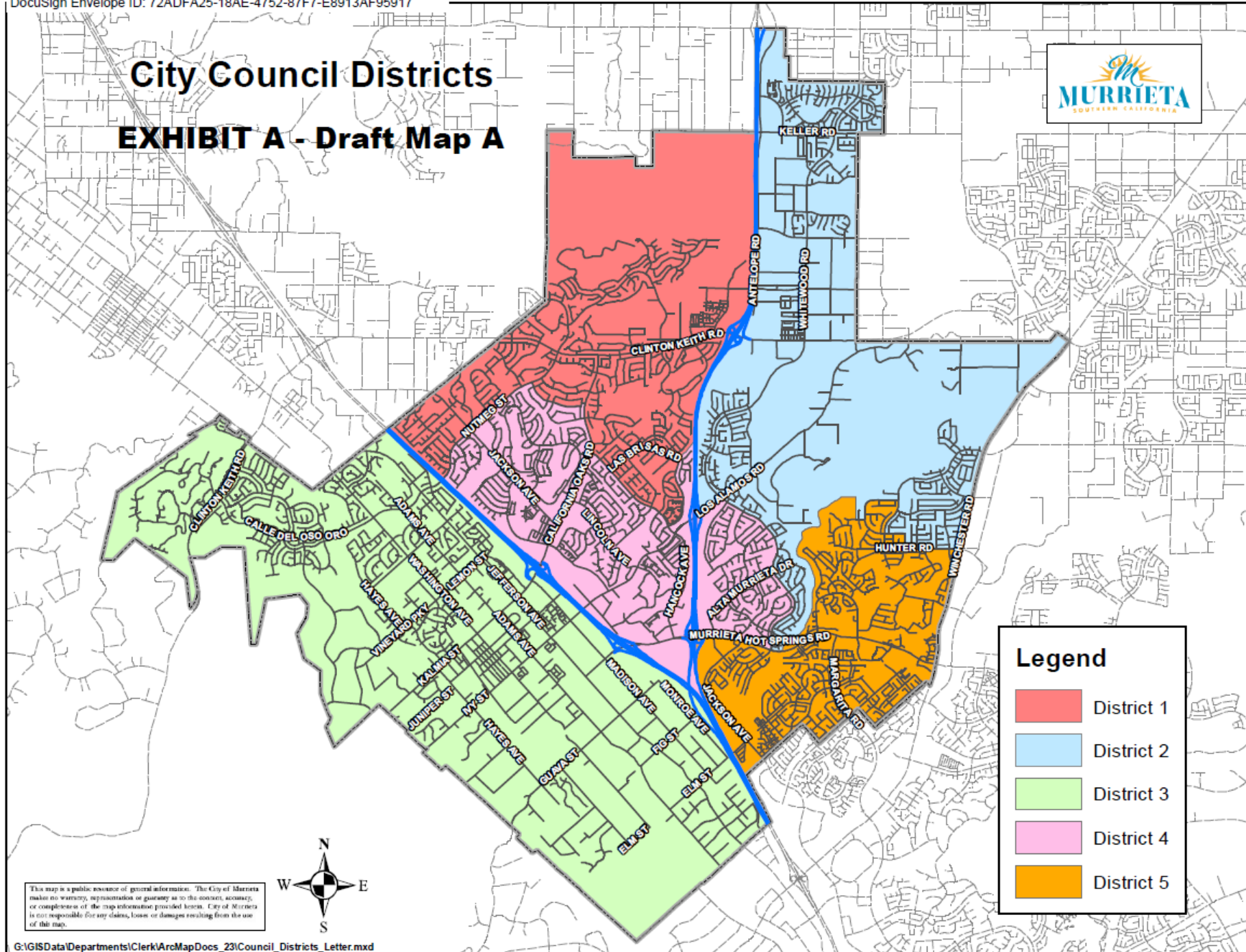
