

RESOLUTION NO. 26-4965

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MURRIETA,
CALIFORNIA, ACCEPTING A FISCAL YEAR 2025 EMERGENCY
MANAGEMENT PERFORMANCE GRANT**

WHEREAS, on June 3, 2025, the City Council of the City of Murrieta adopted Resolution No. 25-4837 approving the Operating Budget for Fiscal Years 2025/26 and 2026/27; and

WHEREAS, the City of Murrieta Fire Department submitted a grant application to the County of Riverside Office of Emergency Services under the U.S Department of Homeland Security; and

WHEREAS, on June 24, 2026, the City of Murrieta received a grant award for the Fiscal Year 2025 Emergency Management Performance Grant program in the amount of \$11,137 (the “Grant”); and

WHEREAS, the terms of the Grant provide a dollar-for-dollar local match totaling \$11,137; and

WHEREAS, sufficient funding for the local match requirement is available in the Murrieta Fire District’s 2026/27 Operating Budget.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MURRIETA,
CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS**

Section 1. The recitals above are true and correct and incorporated herein by this reference.

Section 2. The City of Murrieta accepts the grant award of the Fiscal Year 2025 Emergency Management Performance Grant award in the amount of \$11,137, and the terms of the Grant are hereby accepted.

Section 3. The Fiscal Year 2026/27 Operating Budget, as adopted by Resolution No. 25-4837, is amended to allocate Fiscal Year 2025 Emergency Management Performance Grant funds to the Homeland Security grant revenue and expenditure budgets, and increasing grant revenues and grant expenditures in Fund 377 by \$11,137.

Section 4. The City Manager, or their designee, is authorized to sign and submit all necessary grant-related documents and take actions required to accept and implement the Grant.
