
Much of what our SAFE Family Justice Centers do would not be possible without the valued support of our many community partner organizations, and you! Our organization was founded over 25 years ago as a grassroots effort in Temecula and Murrieta by several community-minded people who truly cared about the families and children who were negatively impacted by domestic violence. In these situations, law enforcement is limited to investigate the immediate crime and arrest, but is not equipped to deal with the long-term emotional and financial impacts to the victims, including navigating the complex criminal justice and civil court systems. That is where we step in.

Our founders all believed there was something more that could, and should, be done to empower victims to live freely and independently from their domestic violence abusers and “break the cycle”. Therefore, in December 1998, Safe Alternatives for Everyone (SAFE) was incorporated as a local non-profit organization to exclusively serve and provide wrap-around services to domestic violence victims and work directly with local government and other non-profit organizations to better serve and equip crime victims.

Today, we will publicly recognize several of the key individuals who helped shape this organization into what it is today. Our physical centers in Riverside and Indio are sponsored by the Riverside County District Attorney’s Office and the Temecula Center is sponsored by the City of Temecula. These partners have enabled the SAFE Family Justice Centers to have the county reach we have today and to serve victims of abuse and violence across this vast county.

On May 9, 1993, Allison Jacobs and Sheriff's Deputy Kent Hintergardt tragically lost their lives, and SAFE Family Justice Centers continues to honor their memory through its mission to support domestic violence survivors. Domestic violence remains one of the leading causes of homelessness for women, and victims often face the risk of returning to unsafe environments without access to secure housing. Thanks to a generous donor, Alli's House provides a safe, temporary refuge, ensuring survivors have the stability they need to rebuild their lives and avoid the dangers of homelessness. This vital resource reduces the risk of recurring violence and the need for repeated law enforcement intervention.

Breaking the Cycle of Abuse

I grew up watching my mom being abused by different men, the cops coming to our house was normal and frequent, I was taught to stay quiet if the cops or CPS came, they were the enemy. Loud parties through the week and weekends with drugs, alcohol and my moms friends from her gang partied at our house, I grew up thinking that was normal. I didn't know it at the time, but I was stressed out as a child and always on high alert, waiting for something bad to happen. I had trauma, I was an angry kid fighting all the time and hanging out in the streets with the wrong crowd. I got pregnant and had a child at 14, decided I didn't want her to grow up the way I did because I didn't want that to be her lifestyle. When my daughter was two we moved to Riverside county to my grandma's ranch where it was quiet and peaceful, I finished high school and started working, not until after I was in a domestic violence situation three years ago and my abuser was sentenced to prison would I break free and start to heal with the help of therapy, and the SAFE FJC's support.

The Safe Family Justice Centers has not left my family's side since meeting them. They have made sure my children are involved in trips, classes, groups, events, made sure we've had Thanksgiving and Christmas, and have supported us in so many different ways. SFJC have involved me in Women's Aftercare which has helped me see that I wasn't alone and provided a safe space to share with other women that have been through the same situation as I have. The Domestic Violence Education course, which helped me understand that there are many different types of domestic violence, not only physical abuse. SFJC made it possible for me to attend the 40 Hour Domestic Violence Counselor Training, at no cost to me. I am now on a mission to help, and empower others that have been victims of abuse.

My two teenagers attended the Intimate Partner Violence for teens 6 week group and that has empowered them to advocate for themselves and others and are mentors to their peers at school and in our community, they're not afraid to speak up. My children look up to the police and their mentors in the PAL program. I was once scared of the police as a child and young adult, as for my kids they call the police their mentors and friends. Early intervention, and education are crucial to preventing future abuse.

I believe if we provide education, resources, and early intervention for victims it will prevent future abuse, and more people will speak up. It took me so many years to speak up about my child abuse, not until after my DV situation, and I started healing, was I able to speak my truth because I had the support of the SFJC I trusted them which took a lot, and didn't happen over night, especially with my children. Now I can make a difference in victims' lives like the SFJC is continuously doing in mine, and my children's lives.

Adult Programs

Domestic Violence Education

Provides individuals who have experienced domestic violence with the education and tools to understand the cycle of violence, how to safety plan, the barriers to leaving an abusive relationship, the characteristics of healthy relationships, and how to navigate the civil/criminal justice system and community resources.

Women's Aftercare

A support group for women who have experienced trauma to share and explore their experiences with peers, build self-care skills, and encourage one another to live authentically in mind, body, heart, and spirit.

Parent Project

Teaches parents how to effectively handle family conflict and resolution, childhood trauma, teen violence and bullying, teen drug use, media influences, poor school performance, and truancy.

40 Hour DV Counselor Training

Participants are trained on the history, overview, and dynamics of domestic violence, direct client services, the role of an advocate, safety planning, trauma informed care, confidentiality, and mandated reporting. Graduates will become certified Domestic Violence Counselors.

Survivor Story

“The sun always rises, and the sun always sets. It’s up to us what we do in the hours in between. One of my favorite things to do is watch the sun rise and set. The sun rising gives me hope for a new day with new opportunities. At sunset, I like to take a moment and relish all that I have accomplished. **I spent 12.5 years of my life not knowing who I was, besides making my (now ex) husband happy.** However, nothing I did would ever be good enough. I lost my sense of self trying to please him when I was never the cause of his unhappiness. The more

I tried to discover myself as a mother, friend, daughter, professional, and individual, the more aggressive he became.

It was as if my light created his darkness. I got to the point where I was surrounded by a heavy blanket of darkness that I could not see or feel. I was lost. I was never allowed to know about our finances. **I was always to obey.** If I questioned or spoke, he would physically close my mouth for me. Deeper into darkness. I have memories that wake me up sometimes with the fear that it is still happening. I wasn’t allowed to talk to or have friends- especially ones he didn’t approve of (meaning he selected for me). I had trackers on my phone and computer, cameras in the homes, and I was deep in the dark and alone, but never alone- because he was always there. **But for every day and for every night, there is a beautiful sunrise on the horizon. My moment of light was when the judge granted the divorce and sole custody of the kids to me.** It was over. The sun was brighter than ever that day I walked out of the courthouse for the last time. And **now, I enjoy every sunrise and sunset** because it is an adventure to anticipate and a moment to reflect on the wonderful moments of the day. The sun always rises, and the sun always sets regardless.

Survivor Story

I know what it feels like to be punched, slapped, pushed. I know what it feels like to be run over by a car. I know what it feels like to have a knife to your throat and to be poked and sliced. I know what it feels like to be told, “your brains will be blown up and splatter” while they have a gun to your head. I know what it feels like to have full cups crushed in your face. I know what it feels like to be told your dumb, fat, ugly, stupid, crazy and much more I cannot even explain. I know what it feels like to lock myself in a room for hours and days because of fear. I know what it feels like to be lied to. I know what it feels like to be lonely. I know what it feels like to be the person rumors and lies are made about, but you just don’t say anything even though they are not true. **I know what it feels like to be black and blue under my clothes.** I know what it feels like to have a broken nose and black eyes. I know what it feels like when you have mean games played on you that make you feel crazy when you know you are not. **I know what it feels like to feel hopeless.** I know what it feels like to be full of sadness. I know what it feels like to want to explain why you look crazy, but you are just dealing with a lot, so you can’t. **I know what it feels like to have hopes and dreams come true that you never thought possible,** but the impossible is possible not easy, but there is hope when you feel there is no hope! **If you are reading this there is more to your life than you could ever imagine. You are worthy!**

The expense of safely sending one child to camp, where they will benefit from 144 hours of intentional support during the camp week, equals the cost of six clinical therapy sessions.



In 2025, Riverside County PAL will be launching an exciting new archery program designed to empower youth through skill development and outdoor activities. This program, made possible through a grant from USA Archery, will offer participants the chance to learn the fundamentals of archery in a safe and supportive environment. By engaging in this discipline, PAL youth will build focus, patience, and self-confidence, all while enjoying a unique sport that emphasizes both individual growth and team collaboration. The archery program will be open to all skill levels, providing expert instruction and a fun experience for all involved.
