RESOLUTION NO. 25-4887

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MURRIETA, CALIFORNIA, AUTHORIZING THE CITY'S PARTICIPATION IN THE NATIONAL OPIOID LITIGATION SETTLEMENT AGREEMENT WITH PURDUE PHARMA L.P. AND SACKLER FAMILY

WHEREAS, the United States is facing an ongoing public health crisis of opioid abuse, addiction, overdose, and death. The State of California and its local governments spend billions of dollars each year to address the direct consequences of this crisis;

WHEREAS, since 2017, state and local governments in California and throughout the United States have been pursuing litigation against certain distributors, manufacturers and retailers of opioid pharmaceuticals (the "Opioid Defendants") in an effort to hold the Opioid Defendants financially responsible for the impact of the opioid epidemic on the state and local governments, including the City of Murrieta ("City"), and resources necessary to combat the opioid epidemic;

WHEREAS, In 2021, nationwide settlements were reached to resolve all Opioids litigation brought by states and local governments against the largest pharmaceutical distributors: McKesson, Cardinal Health, and AmerisourceBergen ("Distributors"), and manufacturer Janssen Pharmaceuticals, Inc. and its parent company Johnson & Johnson (collectively, "J&J"), Teva, Allergan, CVS, Walgreens, Walmart, and Kroger Co;

WHEREAS, On December 21, 2021, the City Council authorized settlement agreements with McKesson Corporation, Cardinal Health, Inc., AmerisourceBergen Corporation, Johnson & Johnson, Janssen Pharmaceuticals, Inc., Ortho-McNeil-Janssen Pharmaceuticals, Inc., and Janssen Pharmaceutical, Inc, and elected to take direct distribution of settlement payments;

WHEREAS, In March 2024, thirty-three settling states, participating political subdivisions, and Kroger Co reached a settlement agreement totaling \$1.2 billion, which will be paid out over 11 years;

WHEREAS, On July 2, 2024, the City Council authorized settlement agreements with Kroger Co and elected to take direct distribution of settlement payments;

WHEREAS, the City was notified of new national opioid settlements that have been reached between settling states and participating subdivisions against Purdue Pharma L.P. & Sackler family; and

WHEREAS, the City of Murrieta is considered a primary Subdivision that is a General-Purpose Government as defined in the respective Settlement Agreements. The settlement payment allocation will be in accordance with the California State Subdivision Agreement.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MURRIETA, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

- **Section 1.** Authorize the City to participate in the National Opioid Settlement agreement with Purdue Pharma L.P. and Sackler family; and
- **Section 2.** Authorize the City Manager to take all actions necessary to implement the settlement agreements.
