

RESOLUTION NO. 21-4473

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MURRIETA,
CALIFORNIA, RETROACTIVELY APPLYING NEW SIGNATURE EVENT TIER 4 FEE WAIVER
TO THE 2021 TOUR DE MURRIETA BICYCLE RACE

WHEREAS, as a public benefit, the City of Murrieta ("City") offers the public many unique and varied special events, including its Birthday Bash, Holiday Magic celebrations, the Father's Day Car Show, and the Fireman's Barbeque (collectively, "City Events"); and

WHEREAS, in addition to City Events, there is a distinct category of events organized by outside vendors that are large-scale, annual special events that have a cultural and economic benefit and are deemed "Signature Events" by the City Council; and

WHEREAS, Signature Events do not charge admission for the general public and are still required to submit a Special Events application each year; and

WHEREAS, the current list of Signature Events includes the Murrieta Rod Run car show, the Rotary Club's Field of Honor events, the Susan G. Komen Race for a Cure, and the Tour de Murrieta bicycle race; and

WHEREAS, Signature Event organizers typically request support from the City that includes waiving City permit fees, providing traffic assistance and police assistance, closing roads, setting up signage, marketing assistance, as well as clean up and trash pick-up; and

WHEREAS, on July 6, 2021, the Murrieta City Council approved a new tier structure for Signature Events based on years of service to the community; and

WHEREAS, the 2021 Tour de Murrieta bicycle race was originally approved to receive \$5,000 in waivers for in-kind support services and permit fees specific to the events, based on the previous support level for Signature Events; and

WHEREAS, event organizers have requested retroactive funding based on the new tier system, thus requesting an increase in in-kind support from \$5,000 to \$10,000 for the 2021 Tour de Murrieta bicycle race, with any outstanding balance being the responsibility of the event organizers.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Murrieta retroactively approve in-kind funding in the amount of \$10,000 for the 2021 Tour de Murrieta bicycle race.
