

# LAWS GOVERNING ELECTIONS\*




- Voter rolls must be accurate (National Voter Registration Act)
- Votes counted must be from eligible voters (U.S. Constitution)
- **System must be highly accurate (1 error in 125,000 ballots [CA Voting System Standards])**
- **Ballots cast must reconcile with votes counted (California Election Code 15302)**




