Whereas, City and Consultant wish to amend the Agreement as further set forth herein.

Whereas, the Agreement was previously modified by the following prior amendments: Amendment No.1, which extended the agreement to August 31, 2025, and increased the amount not-to-exceed by thirty thousand (\$30,000) dollars.

AMENDMENT

NOW, THEREFORE, it is agreed by and between the parties as follows:

- 1. The above recitals are true and correct.
- 2. The following terms of the Agreement are hereby amended to read as follows:
 - A. Section 3.1 of the Agreement is hereby amended in its entirety to read as follows: "The term of this Agreement shall be from 8/15/2023 until 8/31/2027."
 - B. Section 4.1 of the Agreement is hereby amended in its entirety read as follows: "In consideration of the services to be performed by CONSULTANT for the CITY as set

forth in Section 1, the CITY agrees to pay CONSULTANT a sum not to exceed one-hundred-twenty-thousand (\$120,000) billed as services are rendered based on rates deigned on attached quote/proposal (Exhibit "A") of the original agreement."

3. All other conditions of the Agreement shall continue in full force and effect.
