

RESOLUTION NO. 24-4746

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MURRIETA REPEALING RESOLUTION NO. 08-1992 AND PROVIDING PUBLICATION REQUIREMENTS FOR ORDINANCES BY AUTHORIZING ORDINANCE SUMMARIES AND DESIGNATING AN ORDINANCE SUMMARY OFFICIAL PURSUANT TO CALIFORNIA GOVERNMENT CODE §36933

WHEREAS, as the legislative body takes action via minute orders, resolutions, and ordinances as part of the City of Murrieta's (City) operations and duties; and

WHEREAS, an ordinance is considered the most authoritative form of action taken by the City Council and, as such, requires legal notice; and

WHEREAS, on June 23, 1992, the City Council adopted Resolution No. 92-129, determining ordinances and certain resolutions to be posted and designating posting locations; and

WHEREAS, on September 20, 1994, the City Council adopted Resolution No. 94-326, repealing Resolution No. 92-129 and designating posting locations and the City Clerk to prepare ordinance summaries; and

WHEREAS, on May 6, 2008, the City Council adopted Resolution No. 08-1992, repealing Resolution No. 94-326 and designated posting locations; and

WHEREAS, the City currently publishes ordinance adoptions in their entirety in accordance to legal requirements; and

WHEREAS, ordinance summaries will significantly alleviate a fiscal burden on the City Clerk department budget; and

WHEREAS, California Government Code §41802, the City Attorney shall draft an ordinance required by the legislative body; and

WHEREAS, California Government Code §36933, provides the publication requirement of ordinances, allowing for a designated official appointed by the City Council to prepare a fair and adequate ordinance summary.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MURRIETA, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS

Section 1. The recitals above are true and correct and incorporated herein by this reference.

Section 2. Resolution No. 08-1992 is hereby rescinded and of no further effect.

Section 3. In accordance with California Government Code §36933, the City Manager’s designee will prepare fair and adequate ordinance summaries.

Section 4. The City Clerk will publish the ordinance summaries in accordance with California Government Code §36933, and all applicable laws.

Section 5. The City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.
