

RESOLUTION NO. 25-4830

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
MURRIETA, CALIFORNIA, AMENDING THE LIST OF AUTHORIZED
OFFICIALS ON THE LOCAL INVESTMENT AGENCY FUND**

WHEREAS, the Local Agency Investment Fund is established in the State Treasury under Government Code section 16429.1 et. seq. for the deposit of money of a local agency for purposes of investment by the State Treasurer; and

WHEREAS, the Murrieta City Council previously determined that the deposit and withdrawal of money in the Local Agency Investment Fund in accordance with Government Code section 16429.1 et. seq. for the purpose of investment as provided therein is in the best interests of the City of Murrieta and authorized the deposit and withdrawal of the City of Murrieta's monies in the Local Agency Investment Fund in the State Treasury in accordance with Government Code section 16429.1 et. seq. for the purposes of investment as provided therein; and

WHEREAS, the City Council also previously designating the following positions as authorized to deposit and withdraw monies in the Local Agency Investment Fund: City Manager, Assistant City Manager, and Administrative Services Director; and

WHEREAS, at this time the City Council desires to update the list of authorized positions.

CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

The following City of Murrieta officers holding the title(s) specified herein below or their successors in office are each hereby authorized to order the deposit or withdrawal of monies in the Local Agency Investment Fund and may execute and deliver any and all documents necessary or advisable to effectuate the purposes of this resolution and the transactions contemplated hereby:
