

**AMENDMENT TO THE AGREEMENT WITH

RECITALS

Whereas, City is a general law city, formed and existing pursuant to the provisions of the California Government Code.

Whereas, City and Consultant entered into an Agreement on the Effective Date set forth above for the Services.

Whereas, City and Consultant wish to amend the Agreement as further set forth herein.

Whereas, the Agreement was previously modified by the following prior amendments: N/A

AMENDMENT

NOW, THEREFORE, it is agreed by and between the parties as follows:

1. The above recitals are true and correct.
2. The following terms of the Agreement are hereby amended to read as follows:

A. Pursuant to Section 3.1 of the Agreement, the first option to extend is hereby invoked and the termination date extended to 8/31/2025.

B. Section 4.1. of the Agreement is hereby amended in its entirety read as follows:

"In consideration of the services to be performed by CONSULTANT for the CITY as set forth in Section 1, the CITY agrees to pay CONSULTANT a sum not to exceed sixty-thousand (\$60,000)

billed as services are rendered based on rates defined on attached quote/proposal (Exhibit "A") of the original agreement."

3. All other conditions of the Agreement shall continue in full force and effect.
