

RESOLUTION NO. 24-4747

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MURRIETA DESIGNATING POSTING LOCATIONS IN THE CITY

WHEREAS, on June 23, 1992, the City Council adopted Resolution No. 92-129, determining ordinances and certain resolutions to be posted and designating posting locations; and

WHEREAS, on September 20, 1994, the City Council adopted Resolution No. 94-326, repealing Resolution No. 92-129 and designating posting locations and the City Clerk to prepare ordinance summaries; and

WHEREAS, on May 6, 2008, the City Council adopted Resolution No. 08-1992, repealing Resolution No. 94-326 and designated posting locations; and

WHEREAS, the City currently posts various notices, agendas, and documents in accordance with legal requirements in three locations in the City: City Hall, Fire Station No. 2, and the Murrieta Public Library; and

WHEREAS, on June 18, 2024, the City Council adopted Resolution No. 24-4746, repealing Resolution No. 08-1992, and updated the publication and posting requirements for Ordinances; and

WHEREAS, after review of proposed City properties and availability for postings, the above locations meet City obligations; and

WHEREAS, in the future, the City Clerk will request funding for digital boards which will provide public noticing exposure to each district.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MURRIETA, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS

Section 1. The recitals above are true and correct and incorporated herein by this reference.

Section 2. The City Council designates the three (3) locations as official post locations:

1. City Hall
1 Town Square
Murrieta CA 92562
2. Fire Station No. 2
40060 California Oaks Road
Murrieta CA 92562

3. Murrieta Public Library
8 Town Square
Murrieta CA 92562

Section 3. The City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.
